



Jobs (2020)

Compensation

Job posting activity is about average in San Diego-Chula Vista-Carlsbad, CA. The national average for an area this size is 271* job postings/mo, while there are 266 here.

















Retirement Risk Is Low, While Overall Diversity Is High




Retiring Soon

Racial Diversity




Occupation Race/Ethnicity Breakdown
