- 1. Academic Senate Elections Angela Nesta The Senate website now shows the spring 2017 election candidates. After Spring Break, a call out for nominations will be sent out for the part-time faculty senators. Once the full slate of candidates are set there will be two ballots sent out. One to the full-time faculty and one to the part-time faculty. Also, during the course of the elections discussion, Seth Slater declared that he wished to nominate Robert Stafford, a part-time faculty member, for the office of Academic Senate President, because no full-time faculty member had yet been nominated for that office, but the part-time nomination was disallowed on the basis of our bylaws.

- A. Enrollment Trends and Strategies: Dr. Julianna Barnes, President, reviewed and discussed the importance of enrollment. She gave an overview of the College's current numbers in enrollment. She also discussed the different enrollment trends and strategies the College will be exploring to keep enrollment steady and growing.

  The College would also like to develop strategies to increase our enrollments in ESL courses even though there is limited space on campus for those courses. Targeting private schools, expanding dual enrollment and offering a study abroad program at Cuyamaca College were also discussed.
