II. President's Report --

A. Announcements

1. **Position Openings.** The positions of Curriculum Co-chair (.40 reassigned) and Tenure Review Coordinator (.10 reassigned) were announced to the Cuyamaca faculty, and some applications have already been submitted. Two more positions will soon be formally announced are: SLO Coordinator (.30 reassigned) and Faculty Accreditation Co-Chair (.6 reassigned).

- 2.**IEPI** (Institutional Effectiveness Partnerships Initiative): An IEPI team will visit Cuyamaca College all day on May 2nd, and at 9:30am the team will meet with senate officers in Room I-209. Everyone is welcome to come.

- B. *ASCCC: Spring Plenary, April 20-22* -- Kim Dudzik, President-Elect of the Academic Senate discussed her experience at the Spring Plenary of the Academic Senate for the California Community Colleges.
- C. District & College Committee/Council, and Other Institutional Updates
 1. East County Education Alliance: Dual Enrollment -- MOU progress --

The Dual Enrollment Subcommittee met on April 27th to work on the Memorandum of Understanding that is required by AB 288. With primary focus on CTE courses, the subcommittee worked to develop a list of specific courses and program that Cuyamaca and Grossmont Colleges could offer at various of the ten high schools of the GUHSD.

- 2. **Compressed Calendar Task Force** -- Update -At present, the respective surveys that will be sent out to staff and students are still in development. It is not yet known if the surveys will be ready in time to be distributed during the Spring 2017 semester.
- 3. *Part-Time Senator Elections*. Angela Nesta reported that three Part-Time senators have been elected:
 - Asma Yassi (Counseling) as the Part-Time Faculty Senator for Student Services, with 17 votes;
 - Robert Stafford (English) as the Part-Time Faculty Senator for Instruction, with 16 votes;
 - Kim Bailey (English) as Part-Time Faculty Senator-at-Large with 12 votes.
- 4. *Voluntary Dues Fund* Kim Dudzik reported that a total of \$337 had been collected. She then held an opportunity drawing into which were entered the names of those who had contributed to the fund. Jodi Reed's name was drawn, with the prizes being a pair of tickets to the Old Globe's *Hamlet* on September 8th and a \$50 certificate to the Prado Restaurant.
- 5. *The Academic Rank Committee* has approved the advancement of Mary Asher-Fitzpatrick to the rank of professor.

- **VI. Information** (First readings and updates for future action)
 - A. Curriculum Packet for the Governing Board Meeting of May 16 -- Chuck Charter, Faculty Co-Chair of the Curriculum Committee, reviewed the contents of the curriculum packet with the Senate.
 - B. *Program Review & Planning: Revisions to Templates for Annual Updates* -- Bri Hays, Senior Dean of Instructional Effectiveness, Success and Equity, reviewed the contextual background of the College's current effort to streamline our program review processes. Some of the concerns that faculty and staff have expressed regarding our program review processes include: general lack of engagement in the process; system challenges with TracDat; no program-review alignment between the College's main divisions; confusing planning timelines; and data not easily accessible for program review and planning.
 - 1. **Instruction** (IPRPC) -- Dan Curtis pointed out that there are four program review committees on campus, and that we want to get all four aligned in regard to their timelines, forms and processes. Dan also reviewed the instructional area's template.
 - 2. **Student Services** (SSPRPC) -- Beth Viersen reviewed the template for Student Services Areas, and pointed out that it was quite similar to that for Instruction.
 - C. *Proposed Revisions to the Charge of the Research Committee* -- Bri Hays and Tammi Marshall Bri reviewed the proposed changes to the Research Committee, which will include the name change to Institutional Effectiveness Committee.
 - D. East County Education Alliance Endorsement of the ECEA Blueprint for Success: Vision, Mission, and Goals. This was changed from an action item to an information item, and will probably not return to the Senate for a vote. Academic Senate President, Paul Carmona will simply forward the Senate's feedback to the ECEA.

A. Technology Planning Committee -- Endorsement of the Committee's Proposed Ranking of Funding Requests. Resolution:

Be it resolved that the Academic Senate for Cuyamaca College endorse the funding-request rankings for 2017-2018, as submitted by the Technology Planning Committee.

B. Create the Framework for an Honors Program. Resolution:

Be it resolved that the Academic Senate for Cuyamaca College authorize the Honors Program Task force to create the framework for an Honors Program that will (1) mirror that of Mount San Jacinto College, (2) lead to UCLA TAP Certification, and (3) allow departments to develop specific requirements for their students.
