II. President's Report --

A. Announcements

- 1. Faculty Kudos Kim Dudzik highlighted and acknowledged the work of Student Services faculty. Faculty mentioned were My Linh Nguyen, who was instrumental in the Ed Plan Clinics that occurred around campus which resulted in many appointments for students to meet with counselors. Within STEM faculty mentioned were Osvaldo Torres and Hieu Huynh who are making the rounds in science classrooms, signing up students to help them construct Ed plans. All of counseling was acknowledged for help with the acceleration in ESL. The Transfer Center has served around 300 students starting in October until now, helping with CSU and UC applications. These students are served between Amaliya Blyumin and part time faculty counselor, Alisa Rowland.
- 2. **Faculty Feedback** Kim Dudzik set aside time for faculty to identify collective interests for the Academic Senate President to bring to appropriate parties.
- a. Kim Dudzik would like to send a team to Senate Plenary each semester. There is a need to get more people to go to Senate Plenary to help foster a shared governance culture on campus. Kim would like to include two or three people and conversations with administration and professional development have started in order to secure funding. The next one is April 12-14th and will be held in San Francisco.

- 2. Senate Plenary Update the State Academic Senate passed the following resolutions: PDC (Professional Development College) will add professional development courses in effective teaching practices. Endorsing Support for Educational Planning Initiative's Suite of Tools and how it is needed for students, counselors and some faculty. A suggestion was made for our senate to construct a resolution. A consortium approach to expanding online educational opportunities with existing community college resources. A resolution to align transfer pathways for the CSU and UC systems since requirements differ for both. For information on the resolutions and presentation materials, visit asccc.org
- 3. Hiring and Professional Development Taskforces (District) The Search and Hire Task Force, was created to review current search/hire processes and make recommendations for improvements (through the lens of our vision, mission, and strategic priorities). The Professional Development Task Force will coordinate professional development efforts across the colleges/district.
- 4. East County Education Alliance According to AB 19: The community college may use funding appropriated pursuant to this article to waive some or all of the fees for the **first-time** community college students who are enrolled at the college **full time**. "Full time" means 12 or more semester units or the equivalent. This was signed into law and poses a problem for our area, as many students enter our college on a part time basis. Therefore, the Higher Edge Promise Scholarship is on hold.
