## D. District & College Committee/Council, and Other Institutional Updates

1. Curt Sharon, CIS faculty, shared information on Windows 10 and cyber security: Curt Sharon announced that it is susceptible to get hacked on campus. When Cuyamaca College rolls out windows 10, admin rights will be revoked during the process. Microsoft will stop supporting Windows 7 in January 2020. The education sector has the highest number of breaches. There have been 350 data breaches in the past eight years. What Cuyamaca College will do: District IT security workgroup,

cyber security training, two factor authentication, updating infrastructure, district data policy in progress, and controlling admin access. This means you can't download and install software independently. To obtain software at Cuyamaca College, contact the help desk, Microsoft store or fill out a software request form.

- 2. Tammi Marshall, Institutional Effectiveness Committee Co-Chair, shared information on the CCCCO Vision for Success plan for local goal setting: Vision for success As a part of this, new score card metrics have been developed. Every year it is required to submit a one year goal. A report is created and then gets submitted and sent out every year and approved by the college council and senate. IEPI metrics are going away and the new vision for success score card metrics have been introduced. As part of this, by December 15 a plan has to be developed to establish how to take the data points and align them with the metric score card data points. In the past, the updated data points were due by June 30. Now they need to be updated by May 31 and have to be board approved. This will come back to the Academic Senate on May 9.
