

How are course sections marked ZTC?

- ZTC means there are zero textbook costs to the student because:
 - Faculty adopted, adapted, curated, or created an open education resource; OR
 - Faculty/department/division worked with Library to make sure course materials are freely accessible through Library; OR
 - Department/Division purchased commercially available course materials; OR
 - Some combination of the above.
- Faculty make their course section ZTC by choice due to 10+1.
- Department Chairs, in developing line sheets, should ask faculty if their course section is ZTC and, if ZTC, how was it achieved by the faculty.
- Division Deans should ask Chairs to ask Faculty if their course sections are ZTC or not ZTC.
- Division Deans send line sheets to Instructional Operations, and IOPS will include  symbol on online class schedule.

What about Low Textbook Cost (LTC)?

- Low Textbook Cost (LTC) is a course-section designation that is the result of a faculty member exercising 10+1.
- LTC is defined as total cost of course materials being less than or equal to \$40.
- How to get LTC designation on my course-section?
 - Faculty should let their Chair know.
 - Department Chair/Discipline Lead should include LTC designation in their draft line sheets.
 - Deans should ask chairs to ask faculty if their course is LTC.

Background

Background

- State of California allocated \$115,000,000 in one-time funding to CCCCCO for Zero Textbook Costs (ZTC).
- ZTC Planning Grant and ZTC Implementation Grant
 - Our campus has already received and expended \$20,000 ZTC Planning Grant
 - Our campus has not yet allocated the \$180,000 ZTC Implementation Grant to a program to create a ZTC degree or certificate.
 - In May 2023, the Academic Senate approved a process for faculty to apply for \$180,000 ZTC Implementation Grant Funds. Please see this [Presentation](#) for more information.
 - The deadline to submit our plan for using ZTC IG\$ is October 30, 2023.
 - This ZTC Pathway needs to be implemented no later than Fall 2025.
- ZTC Acceleration Grants
 - This is new program within the ZTC framework and discussed in later slides.
 - Our campus can apply for as many grants as we have faculty interest and capacity to execute.
 - See new [CCCCCO Memo ESS 23-37](#) issued 8/21/23.



ZTC = Opportunity

- Opportunity for faculty to apply their knowledge of their students and expertise of their discipline to:
 - Adopt existing Open Education Resources (OER)
 - Curate existing OER
 - Create new OER
- Opportunity for faculty to lower and eliminate financial barriers for students.
- Opportunity for faculty create instructional materials to share with others.
- OER: instructional materials that are Creative Commons (CC) licensed: freely available, can be stored and shared, and can be changed and/or combined

 - 58 Certificate of Achievement programs
- Current ZTC Pathways
 - POSC
 - Students would need to take courses here and Grossmont to complete
 - Others?
 - Maybe Arabic, Public Health

Universe of Possible ZTC Courses

- Cuyamaca College has ~830 active courses across 57 disciplines nested in 5 divisions.

How can we achieve ZTC degrees or certificates?

- Faculty willingness is paramount
- ZTC degrees/certificates contain a set of courses, and each course in set must have at least 1 ZTC section offering.
 - Degrees: Discipline Specific AND General Education
 - Certificates: Typically Discipline Specific ONLY
- Course can become ZTC in any of the following ways:
 - Course is already ZTC.
 - Adoption of existing OER.
 - Adaptation of existing OER.
 - Curation of existing OER.
 - Creation of new material (texts or ancillary materials) with a Creative Commons license (which we will help you obtain).
 - Use of Library Materials.
 - Purchase class set of books/textbooks (note: this must be sustainable and manageable).

What OER Already Exists?

- Please review existing OER before creating your own in order to avoid duplicating materials.
- Please see the [ASCCC-OERI list of OER by discipline](#) and by Transfer Model Curriculum.
- [LibreTexts](#) also offers a comprehensive list of resources by discipline.
- [OER Commons](#) is another repository to check.
- All new material must be made accessible, freely available (with use of Creative Commons license that we will help you obtain), and included in a repository (such as Canvas Commons or LibreTexts).

Narrow ZTC versus Wide ZTC

- Narrow ZTC

- Each course in program has at least 1 ZTC section
- Example:
 - Students can complete POSC AA-T by completing ZTC courses at both Cuyamaca College and Grossmont College
 - Few POSC courses offered at Grossmont College are ZTC

- Wide ZTC

- Each course in program has 2 or more ZTC sections.
- Example:
 - Students can complete POSC AA-T by completing ZTC courses at both Cuyamaca College and Grossmont College
 - All POSC courses offered at Cuyamaca College are ZTC

Re: Complexity

- Table in prior slide includes whether courses were offered as ZTC in SP23 or FA23, and which part of MATH AS-T, ECE AS, or PHYC AS-T degrees they associate with (Core, List A, etc.).
- As you can see there are 18 courses, 3 of which are ZTC.
 - A few more are in progress towards ZTC
- I have corresponded with Discipline Leads or Chairs since Wednesday afternoon.
- 15 courses across 5 disciplines would need to become ZTC and, in theory, we can submit three \$200K proposals.
- This does not include conversation about GE portions of these degree programs.

ZTC Implementation Grant

- The college received \$180,000 through apportionment
- The OER Committee developed a process and rubric for awarding this grant to a degree program or certificate program
- The college needs to submit its ZTC Implementation Grant to CCCCO via NOVA by October 30, 2023

Who Can Apply for ZTC Implementation Grant Funding?

- **Individual Faculty for single course**
 - All faculty (full-time and part-time) are welcome to apply for funding. The Individual Faculty Interest Form for Cuyamaca College's ZTC Pathway Grant is for an individual faculty to make a course they teach zero textbook cost.
- **Faculty Teams for entire certificate/degree pathway**
 - The Faculty Team Application for Cuyamaca College's ZTC Pathway Grant is for a team of 2 or more faculty to complete a ZTC Pathway that will make **ALL** courses in the specified certificate or degree program zero textbook cost.
- **Faculty are encouraged to include students in their ZTC project or program.**
 - Author sections, co-author sections, graphic arts, videos, etc.

4-Part Recommendation from OER Committee to Academic Senate

1. Timeline for Process for faculty at the college

- We will essentially have a rolling process starting summer 2023 or fall 2023.

- The Individual Faculty Interest Form for Cuyamaca College's ZTC Pathway Grant is for an individual faculty to make a course they teach zero textbook cost.


3. Faculty Team [Application](#):

ZTC Acceleration Grants

ZTC Acceleration Grants Part 1/2

- In addition to the ZTC Planning Grant and ZTC Implementation Grant, each campus can now apply for one or more ZTC Acceleration Grants.
- Each campus can apply for as many ZTC Acceleration Grants as it has faculty interest for and the capacity to execute.
- Each application can be up to \$200,000 to develop and implement a ZTC Pathway.

ZTC Acceleration Grants Part 2/2

- Recall, each application can be up to \$200,000 to develop and implement a ZTC Pathway.
- Deadline to apply WAS Friday, September 15, 2023 and is now Wednesday, November 15, 2023.
- CCCCO will determine which applications are awarded or not.
- Any ZTC Pathway needs to be implemented starting no later than Fall 2026.
